## **Artist's Village Information & Application**

**Location:** Government Dr - World's Fair Pavilion - Forest Park      **Estimated Attendance:** 35,000

**Dates & Times:**      Friday, August 16th 5 pm to 10 pm  
Saturday, August 17th 11 am to 9 pm  
Sunday, August 18th 11 am to 9 pm

**The Details:** We will provide a first class artistic experience for guests, representing a diverse collection of live-artists and artisanal vendors ranging in a variety of mediums & creations. In order to maintain the highest standards in showcasing your talents & creations the following guidelines are necessary of those wishing to participate:

- Each artist/vendor will submit photo examples of their products/artwork (with pricing) prior to the World's Fare. In the event of artist type duplication, priority to serve particular artist types will be given to the earliest received application. Each participant must sign and return the Hold Harmless Agreement (attached to application).
- The St. Louis World's Fare reserves the right to photograph/video all vendors and anyone they employ including interactions with guests, art, or vended items.
- The St. Louis World's Fare reserves the right to restrict vendors with respect to inappropriate display materials and/or operations. (We do not wish to censor anyone, but because this is a family event, adult themes, graphic imagery, vulgar messages, etc, must be sectioned off in a corner of your area to be viewed only by adults.)
- Vendors are prohibited from possessing illegal substances on or anywhere near the St. Louis World's Fare.

**St. Louis World's Fare will provide:** Extensive event marketing throughout the city and beyond from local media outlets to mass social media marketing, as well as, network advertising and grassroots efforts through our partners, sponsors, local businesses, shops, schools, and community centers.

**Things to Bring:** Participants must provide their own chairs along with any equipment needed to satisfy the individual needs for participation. If your chosen space needs a tent and/or tables, feel free to bring your own; tents can also be provided by us, for an additional fee. All tents must be approved by Artist's Village Director.

**Booth Options:** The Artist's Village will offer 4 different space options giving you multiple ways to be involved; *some of which are at little or no cost to you.* We encourage you to decide the best route for your own individual involvement, and consider what you are willing to bring versus what we will be able to provide for you.

*Artist's Village applications will be taken **through July 31, 2019.** All artists must be approved by the art director before they may be allowed to paint/vend at the festival.*

**Option 1 (FREE)** Live Painting - FREE 5x5 Space, **without** electricity for possible nighttime painting. All live painters are allowed to sell & display three pieces of art (Two on the ground, one on their respective easel). Your name/website will not be listed on STLWF website or program.

**Option 2 (\$50)** Live Painting - 5 x 5 space, **with** electricity, name and hyperlinked website included on STLWF website, listed in Event program. All live painters are allowed to sell & display three pieces of art (Two on the ground, one on their respective easel).

**NOTE:** Live-artists are not allowed to bring tables for displaying ( a small table for your art supplies is allowed), for there will not be enough space. If you need a table to sell and display your art, we recommend grabbing a 10x10 or 10x20 vending space, in which you may create your art live, as well as vend any pieces or prints that you would like.

**Option 3 (\$100)** 10x10 Space - Vending/Painting (You provide tent & tables) Includes electricity, website/program inclusion and social media promotion.

**Option 4 (\$150)** 10x20 Space - Vending/Painting (You provide tent & tables) Includes electricity, website/program inclusion, social media promotion.

**Add Ons: (These are additional costs to options 3 & 4)**

10x10 tent & one 6' table (\$100)

10x20 tent & one 6' table (\$200)

***All returning artists will receive 20\$ off their total costs. This includes anyone who has ever vended or created at any of the past STLWF events!***

In consideration of all the work done by the vendor or participant in the 2016 St. Louis World's Fare Heritage Festival, he/she hereby indemnifies and holds harmless the City of St. Louis, St. Louis Worlds Fare LLC, its Board members, their officers, agents and their employees from any personal injury costs and expenses, occurring to anyone in, or about the area of said vending/displaying of goods and/or services. The participant is acting as an independent contractor not under the continuing supervision and control of St. Louis Worlds Fare LLC, or the City of St. Louis, and agrees that St. Louis Worlds Fare LLC and the City of St. Louis shall not, under any circumstances, be liable under or by any reason of the Agreement, directly or indirectly, for any accident, injury, breakage, or damage to property or persons whatsoever growing out of any activities laws, ordinances, regulations guidelines and rules. Participant agrees to be responsible for all employees, agents and contractors of participant's area. Any concessionaire or employee, agent or contractor of vendor/participant who violates any such law, ordinance, regulations, guideline or rule in connection with the questions of the vended area shall forfeit the vendor/participant and be disqualified from participating in the St. Louis Worlds Fare in the future. In this event, participant shall cease all business activities and vacate the premises immediately forfeiting all fees and deposits
